• Adam Snook, Community Safety Program Director (15mins)

Adam Snook: Also work for the clerk of elections. I was there dealing with all the students on Tuesday, but I would request that next time you all use registration cards from this county instead of Alameda county. We had 300-500 provisional ballots at every voting booth. It is very important that we take them down to the county clerks office within the deadline. You all did a great job, surprised by the outcome. We started night shuttles on the weekends for students that are downtown from $11 \ \text{pm} - 3 \ \text{am}$ on Friday and Saturday nights. Have CSO's in the libraries and all of the residential communities. Im happy to see you all. I was the vice chair of Oakes senate before and im really here to answer questions:

Meganna: Where do the shuttles go exactly?

Adam: There is a pamphlet that TAPS has in order for you to see the route and time and you can also go online to see the route. They run 2 different shuttles every night on a $\frac{1}{2}$ hour time.

Adam: Do you know what to do if you have complaints of a community safety officer?

You can get a feedback from my staff and you can also go on our website to file those complaints. We are here to ensure that everyone is safe

Shiku: Have you ever programmed with students in the past?

Adam: Not directly, just because there are so many students. We are happy to provide security and safety procedures on campus. We are happy to make sure that you all are safe. If you all have any questions after I leave my email is snook@ucsc.edu. I'm not here during the day. Afternoons and evenings I'm happy to help out.

Shaz: Can you talk more about this escort program?

Adam: Preliminary meeting. Its something that I don't have too much sway over and it's a costly program. There needs to be a lot of money that needs to be at the for front and there needs to be a lot of revisions through different departments but its really the police chief that will spear head the program. In the past, we have tried to do them but the customer base wasn't really there. Any escort program that we hire to do that, and if they do anything illegal, it will come back to the university.

Shiku: Isnt there a service that you can call CSO's to walk you back home?

Adam: This would be a different program. SCO's can only cover up to a specific region. Explain your needs and we will try to help you out.

Shaz: What do you think of blue lights on campus, do we need more?

Adam: As far as blue lights, people are not using them serious and when you hit a blue light it is a 911 call. Its better that you just call the campus police number. I was here when we started the original bluelight program and I was a part of choosing the locations for blue lights. With the recommendations the SUA puts forward, you are taking time away from other projects or preventing new projects form happening.

Ivan: For the housing procedures, how transparent are the policies between CSO's and people who live in the

Adam: There is a penul code that talks about university property, residents living on UC property even if you sign a lease with us, you have the rights of people who sign a lease of any property in California. The only conditions we can enter is: if there is smoke coming out of the doors, blood spilling out, or if we feel that there are folks that are in immediate danger.
