Under my duties as Chair of the Student Union Assembly and Article III Section A of the SUA Constitution, I present my May 2014 monthly report and evaluation to the Assembly. ## Completed projects, campaigns, events, or activities

- SUA Elections total voter turnout was 24%. This year we didn't have classroom flyering; however, last year was 27% which would make it a statistical difference, classroom flyering doesn't have a huge effect on voter turnout. Personally, there wasn't that much campaigning from any of the candidates or referendum authors as seen in previous years. There was a similar turnout out on measures this year as last year which would suggest no change. The elections commissioner only received one official complaint, but it was dismissed early on. This is the first year in many years the commission did not go to a hearing which is a victory for the SUA and the Commission.
- As one of two undergraduate students on the judicial board, we are currently hearing an appeals case. However, all information related to this case is confidential.
- The Chief of Police formed an advisory council, myself and one of the Executive Assistants currently sits on this council as the undergrad representatives in hopes of bridging communication between campus police and the student body.
- The SUA budget is on-going and is expected to conclude on May 27<sup>th</sup> to pass the fiscal budget for 2014-2015.

They have had meetings with Alison Galloway, but haven't had any luck. Unfortunately, they are no placing all the blame on SUA for not supporting them in their efforts. Furthermore, the SUA can't take a stance on an issue when a good majority of undergrad did not support the tactic to block off the campus. I have offered my support to the GSA President, and offered some advice for him and I to meet with Galloway and the Chief of Police. It's unfortunate the GSA didn't reach out to the SUA before making their negative statements towards us.
- There was a lot of confusion around UCSC's Got Talent. Just with every event, there needs to be more clear and cut communication across the board and with all of the organizers with expectations of the event.
