

 - The health center and CAPS is currently looking to hire and multicultural psychotherapist. We have interviewed three highly qualified applicants, and currently in the process of recommending an applicant to Gary Dunn who is the Director of CAPS.
- SUA Budget
 - We are working on the SUA budget by condensing many of the activity codes and switching from a shadow system to info view. We are going to process our updated budget with the current ledger once a month and have it publicly available for students to view. This process is almost finished. We started this in the beginning of September and should be done by October
- SUA Transition
 - We are currently working on how to transfer logistics, budget, advising, and operations under the Dean of Students office.
 - Our Operations Manager is also stepping down from her position for family reasons, and this is on the same timeline as the transition. The transition plans to happen on October 11th.
- Slug Shuttle is going to be brought back in collaboration between the SUA and TAPS. I do plan to push a measure during the emergency fall election that will be taking place. However, this service will be available for students, one-way travel from UCSC to San Jose Diridon and Mineta International airport for a \$15 fee. I'm also going to run a student fee referendum in the fall special elections.
- Meeting with Nader: I am working with Nader and EVC Milgram to create a student run escort service that will be available from Sundays to Thursday

Total number of hours worked: 184 hours (minimum required 136 hours)

September monthly review and areas of improvements:

- Transition Process and SOAR. There has been a lot of confusion on the intention of the transition and our campaign for SOAR. We want to support SOAR in any way we can and to make sure that administration knows that we aren't complaining but just requesting for more funding and backing to student organizations. I was notified that the Main Stage still has problems with not only funding but about the unionized theater FTE who has been giving a hard time to ISO, Los Mejicas and FSA. This is one of the issues that we need to head on. Transition process between Dean of Students and SOAR has begun, we have been working on a timeline and logistical planning.
- Our operations manager has notified us that she will be stepping down from her position as operations manager in the next few weeks for family reasons. I'll be coordinating on how to move forward on a smooth transition and delegation of responsibilities since I have to know where the workload will be going and may have to look into hiring student workers.
