We will be meeting again to discuss further issues and recommendations.

Engaging Education

The Board Meeting for Engaging Education was cancelled this month because of scheduling conflicts with many of the Student Initiated Outreach events taking place during this month, but many of the recommendations were corresponded over email. In addition, there were successful events such as the Student Loan Debt Workshop and the Speaker Blowout that is planned to happen in two weeks. Though the Board didn't meet, Care Council did meet to review the guidelines that had been in place in the fall.

iClicker Loaning Program

I finally moved forward with working with the Science and Engineering iClicker loaning program and was given a green light once I obtain the recharge form for the iClickers. They will be lent out in 3 weeks intervals with the option to renew the check out. I hope to have this running by the summer so that students in classes where iClickers are needed can look to checking them out.
