I had never met Dean Yager before and had only heard about him through the Main Stage issue, but he described the discrepancy in lack of funding the department for a full time staff so that all productions are charged for an outside worker, not just student groups. In addition, they are looking to build a new building near Hahn and would like students on the council.

May review and areas of improvements:

- o For Edge of Eden, I felt the event went really smoothly except I think about the validity of the no ins and outs for the event in terms of safety issues with students all coming much later than anticipated so that the openers were not highly attended in addition to much more excessive "pre-gaming".
- o There was a lot of miscommunication in regards to UCSC's Got Talent with the Dean of Students Office. I felt silenced and like I wasn't a priority though my concerns with the process of removing students from the event was completely valid. Considering student fees are used to put on this event, the process of eliminating certain students based on person bias was an issue brought up, but I was brushed aside and driven to a point that I no longer felt I had the capacity to work on the event.
- I felt the meeting with Dean Yager was really great and wish we had the capacity to have a Town Hall next year about the Main Stage issue, though Dean Yager will be on sabbatical next year.
