- For two meetings this month I met with several departments about the possibilities of a spring concert on the East Field. The discussions this month were based around future subcommittee meetings.
- I met with the Chief of Police regarding safety on and off campus and checked in with how his student staff is doing. Several issues were brought which included the kiosk guards removal.
- On the fourth I represented the undergraduate students of University of California at the month University Committee on Educational Policy. Not many large issues came up and the meeting ended early.
- I met several times this month with the Dean of Students. We discussed several things that involved student life in the university. I also was the undergraduate representative on a new group to create a final feasibility study for the upper quarry amphitheater. This group is chaired by the Dean of Students and will continue throughout the year.
- On the weekend of the 8<sup>th</sup> to the 10<sup>th</sup> I traveled to Santa Monica with the Chair and EVC and met with the Lt. Governor and Alumni Regent regarding the future of higher education. The Lt. Governor mention several times on how education at the CSU and UC need to drastically change.
- On the week of the 4<sup>th</sup> and on, I presented the Slug Shuttle to several college governments, asking for sponsorship for the referenda to be put on the fall special election ballot. After given very short notice from the chair that the IVC office would be taking on the Slug Shuttle project, I was able to get 9 out of 10 colleges to sponsor the referenda, and if given more time, all colleges would have been a reality.
- For two weeks starting on the 6<sup>th</sup>, my office and I met with three different production companies and managers in a bidding/shopping pool to hire for a spring concert. In the end we decided on Jose Olivias who is a part time employee of colleges 9/10 and is a co-owner of Sage productions and has vast experience in student volunteering in events and producing large festivals.
- On the week of the 10<sup>th</sup>, my office and I held interns for 14 people for six Outreach Coordinator spots. The decision was hard as we had several amazing applicants, some who have stayed on as volunteers. Later in the next week we had our first team meeting and I can't be more excited in the quality and diversity of our team. There is a lot of potential and excitement within them and I'm more than happy to cut pay so that they can work with us and for the students.
- On the 22<sup>nd</sup> I toured the Fitness and Recreation Facilities with my intern staff, the Director of OPERS, and the Dean of Students. We toured two facilities, one at Davis, and another at Sac State.
- Later on the 22<sup>nd</sup>, I helped set up, take down, and host the quarterly SCOC event C4: Cross Committee Communication Caucus. The event was well attended and the food was amazing.

### November review and areas of improvements:

- The intern hiring process was long and tedious. The paper work seemed very unnecessary and it took a long time to fill out. A new way of providing hiring documentation should be provided.
- The transition has made it very hard to process transactions and meet with our advisor. Although it is still an improvement upon previous advisor turnaround times, it can still be better. The DoS office should hire a new OM for the officers to process our requests.
- SUA and SCOC meetings have had a rough start due to lacking equipment such as chairs and input cords. There should be more communication with the facilities to make sure we will have the equipment we need ahead of time.
- Running sponsorship for a referenda was hard but still possible. More planning and warning should go into a transition of referenda if someone is planning on passing off a project such as Slug Shuttle.
