Activities for the month of February 2015

SUA Advisor Hiring Process

After the SUA Advisor search committee held in-person interviews for all four candidates, we deselected one candidate and ranked the remaining three. Afterwards, I met with the Dean of Students and Assistant Dean of Students to discuss the candidates' references and make a final decision. At this time, I learned that one of the candidates had withdrawn. Several officers had expressed concerns to me that they had not had ample opportunity to be part of the process, so I asked to have a meeting with all the officers to make a final decision. Council of Presidents Conference Call

I attended a conference call with the Council of Presidents to prepare for our March meeting with UC President Napolitano. One big issue discussed on the call was SCA 1, the proposed amendment to the California Constitution that would strip the University of California of its constitutional autonomy from the state legislature. The Council decided by a unanimous vote that we were opposed to the amendment, in contrast to the University of California Student Association's support. I abstained from the vote, as SUA has not yet discussed the issue and I thus felt I was unable to represent any viewpoint other than my own.
