- I was in contact with SCOC members, including the IVC several times this month. With so much going on with their budget and other transition materials, they have a lot going on that I was able to provide consolation on.
- I've been in contact with the members of the SCANN coalition from the UCSA congress this past month. We are looking to move a resolution or two through the assembly once it starts.
- I reconsidered the intern positions that were posted last year. I have redesigned them so that they are more focused on programing academic events and outreach for any issues that may arise this year.
- Through a few meetings with some of the new staff on CEP this year, I have found that one of the major issues we will be tackling will be the addition of a possible C- grade. I have some major concerns about how this will affect people's GPA requirements for financial aid. It could help students that would normally receive a D but would hurt those that would receive a C. I have asked for some possible scenarios based on real numbers to be played out.

## September review and areas of improvements:

- For future years and outgoing officers, although it is really hard to care about the office once they either graduate or move on from SUA, I highly recommend that they still go through their stuff in the office and decide what they want to keep. Even with plenty of time and warning given, there was still a lot of stuff left in the office that we had to throw out. I was expecting this to not be a problem into the third month but we still find random things to be thrown out in the office to this day.
- Our officer meetings have been gaining traction these last two months. They work really well when everyone shows up and that was not always the case. As the year goes on and our schedules become more impacted, I can't stress enough the point that officers put these meetings as a high priority.

Unfortunately at the same time I was gone, new officer orientation went on even though I scheduled first. I didn't miss out on too much important data, but I think more attention should be given to schedules.
- There was a miscommunication between Orientation staff and us about having an open house. Many students showed up at our door with no one home because orientation said we were having an open house. A clear distinction needs to be made about when officers change with orientation so they know to contact us.
