I will make sure to include the work I am doing as both the President of UCSA and the External Vice President of SUA, UCSC.

- UCSA September Board Meeting UC Merced: 9/9 9/10
- UC Regents Meeting UC San Diego: 9/12 9/14
  - Met with <u>UC Student Affairs</u> before attending the September Regents meeting
    - Items discussed:
      - DACA & Sanctuary UC Comprehensive Immigration Reform
      - UCSA's New "We Are 3D" Campaign
      - UCSA's Graduate Professional Student Agenda
      - Preparation to Present Standard of Living to President Napolitano
  - Addressed the UC Regents for the first time <u>President Speech</u>
  - Focused on building relationships with the Regents and UC stakeholders
  - Followed up immediately after
- Undocumented Student Coalition Action Plan: 9/16 9/17
  - Drafted an action plan as requested by the Undocumented Student Coalition
  - Received input from the Execs
  - Offered to connect the coalition with Crystal Martinez, Director of UC Federal Gov. Relations (UCFGR)
  - Took the chance to edit my statement

- <u>Sacramento Trip</u> : 9/21 9/22
  - Purpose: Introduction to coalition partners and key legislative staff who influence the UC budget process and help shape our policy priorities for the year.

- Met with: Campaign for College Opportunity; Meredith Turner, UCOP State Government Relations; CA Student Aid Commission (CSAC); Governor's Office (with Cal Bears!!); and Jeanice Warden Washington, Assembly Higher Ed Committee Chief Consultant
- UCSA/ <u>UCFGR</u> Call: 9/25
  - Discussed UCSA's pause on DACA-related advocacy, UCOP's efforts around undocumented communities, UCOP efforts around Title IX, and a potential federal trip in the spring
- UCOP Budget Consultation: 9/27
  - Discussed standard of living document and how UC system must work on developing systemwide solutions
  - Discussed how UCSA has been reaching out to campus-specific leadership at dining, housing, and finance departments. We will also be presenting this with Napolitano on Oct. 23
  - Deferred maintenance was brought up in the discussion, so I talked about the Cultural Hub in UC Merced and its harmful effects on students
  - Urged transparency of funding for graduate divisions to see where the money is going and to have that data publically accessible.
  - Spoke about how Becky is leading graduate division's advocacy.

  - Responded to media before staff released the President's statement
  - Checked in with staff and Parshan
- "Grade Your Regents" Survey
  - Was contacted by The Daily Bruin because they had questions about the survey
  - I suggested a follow-up after October board meeting
