- The SUA committees need to have more purpose and increased meeting time, aside from scheduled SUA meetings if they are to be successful. As of now, they exist, but do not have active and clear functions of worth.
- I would like to see the Assembly look at ways of passing active legislation that will have powerful effects on our campus, rather than symbolic resolutions.
- Increased communication between the 10 Colleges is fundamental to successful student government. I recommend the Council of Chairs meet more than once per quarter and Stevenson College will make a clear effort to initiate this contact.
- The Student Union Assembly is in need of a formal "Programs Board" within the Internal Affairs Office that is charged with the responsibility of planning and executing large-scale university-wide programs.
- Increased SUA funding or budget reorganization that finances large-scale, university-wide events.
