To the Student Union Assembly,

Under my duties as a College Ten Representative of the Student Union Assembly and Article III, Section A.11 of the SUA Constitution, I present my December 2014 monthly report and evaluation to the Assembly. I will report each month that details the issues, events, and programs that happened that month at College Ten, and evaluates SUA and provides constructive criticism.

In light of finals study hall started Wednesday, December 10<sup>th</sup> and went up until finals week in the Recreation Lounge where snacks and tables were set up for students. There was also free pizza and hot cocoa on Wednesday, December 10<sup>th</sup> at 8pm in the Namaste Lounge. Another event that was held for College Ten students was Pizza with the Provost which gave College Ten students the opportunity to discuss the core course and give any feedback/suggestions they felt were necessary for the provost to consider. A representative was selected from the College Ten Senate to attend the Pizza with the Provost event. Also, a Core Council representative was appointed to attend their weekly meetings. College Ten Senate came to a consensus on next quarter's (Winter 2015) meeting time which would be at 6pm every Thursday in the Terry Freitas Café instead of 8pm which was the original meeting time for College Ten Senate in the Fall 2014 quarter. We also received a funding request from CruzFit to help coordinate their 2015 CruzFit event consisting of a Team Fitness Challenge which would be open for all UCSC students to participate in. College Ten Senate voted on funding CruzFit \$200 with the stipulation that the senate would have to approve the T-shirt design before providing CruzFit with the funding. This stipulation was created due to a conflict College Ten Senate had with CruzFit's T-shirt design last year. A subcommittee was created for the College Ten Senate's annual Winter Retreat. The Winter Retreat is a time for members of the College Ten Senate to get to know each other as well as talk about the budget, constitution, future service projects, etc. The Winter Retreat will be held on Saturday, January 11<sup>th</sup>, 2015 from 1pm-5pm in the Terry Freitas Café. At the last College Ten Senate meeting for the Fall 2014 quarter members began discussing ideas for future service projects. A couple of the ideas for service projects in the Winter 2015 quarter which were discussed include the Bone Marrow Registration Drive, Habitat for Humanity, Homeless Garden Project, beach cleanups, and campus/forest cleanups. The College Ten Senate also began planning a trip to the Martin Luther King Jr. Memorial Convocation which features keynote speakers and honors Dr. King for his work in the Civil Rights Movement. The event is on Wednesday, January 25<sup>th</sup>, 2015 at the Santa Cruz Civic Auditorium. This year's keynote speakers include Angela Davis, and Distinguished Professor Emerita. Lastly the College Ten Senate also received detailed report backs from SUA, SCOC, SUGB, SFAC, and Academic Senate representatives.
