I will report each month that details the issues, events, and programs that happened that month at College Ten, and evaluates SUA and provides constructive criticism.

Since the start of the Winter 2015 quarter, College Ten Senate has begun meeting at 6pm every Thursday in the Terry Freitas Café for weekly meetings instead of 8pm which was the original meeting time in the Fall 2014 quarter.

From Monday, February 9<sup>th</sup> to Thursday, February 12<sup>th</sup> College Nine and College Ten hosted "Sexplosion" which was a series of socials filled with fun activities and games in light of the upcoming holiday, Valentine's Day. Also on Thursday, February 12<sup>th</sup> a College Night was held in the College Nine and Ten Dining Hall. The Winter Formal was held on Friday, February 20<sup>th</sup> from 8pm-midnight in the College Nine and Ten Multipurpose Room. The theme of the dance was Cirque de la Lune and the evening was filled with music, dance, and performances. Tickets were \$4 (\$3 with a voucher), and all proceeds went to the Beach Flats Community Center and the St. Francis Soup Kitchen. Since it was also masquerade themed, mask making for the Winter Formal was held on Wednesday, February 18<sup>th</sup> from 5:30pm-7:30pm in the College Nine and Ten Multipurpose Room. On Thursday, February 26<sup>th</sup> at 6pm American attorney and academic, Anita Hill, gave a public lecture on gender and racial equality in the College Nine and Ten Multipurpose Room. The February Festival, a place for students to come out, express their interest in, and explore the many resources offered here on the UCSC campus, was held on Friday, February 27<sup>th</sup> from 11am-3pm in the College Nine and Ten Multipurpose Room.
