- Working cap for parking specifically for **new** capital projects
 - Like parking lot or new system
 - Maybe it can be used for lights? like smarter light system
 - Ex: no beg buttons and cyclist sensing
- Transit
 - Funded by student fees
 - FY 23 1.5 M towards transit workin cap
 - FY 24 projected 1.25 M
 - FY 23 finished with a balance of 6.5 M
 - This year hopefully 4.7 M on electric buses
 - FY 30 or 31 Measure 72 sunsets and the fees go back down to \$111.5 per quarter per student
- Sustainability budget is not ready
 - TAPS currently does not have a business manager
- Parking has debt, transit does not
 - Debt service on East Remote and Coastal Science Campus
- Zero emission buses (ZEB) forecast
 - o 2024 2 35'
 - 2025 -
 - Looking for grants
 - Already engaged with PG&E
 - Will only pay for the buses in your hands in the next five years
 - Submitted application
 - Will pay for infrastructure, just not buses
 - Planning for adjustment of maintenance cost
 - New
 - Facilities for maintenance, training, batteries, etc
 - \circ Have purchased 4 "gently used" diesel buses for the transition

4. FY 2023 Accomplishments

- Transit
 - Service levels pre pandemic before spring
 - Currently have 31 class B drivers

- Largest roster in years
- Training program
 - Since 2022 graduated 7 drivers
 - 1 trainee currently in the program
- Student program
 - 3 students training
 - When pass the CDL they can apply to be a driver
 - Fill in small gaps nights, weekends, sick
- Electrification Study
 - Working with PG&E to plan
 - Procurement for 2 buses
 - 2 year lead time
- Pilot programs
 - Silicon valley connector
 - Shuttle service to coastal and west side
 - Saferide
- Parking
 - Striping, signage, radar signs, risk and safety services
 - Exploring projects to "improve" parking lots
 - Transit garden and west remote new surfacing and stirping
- Enforcement
 - Last year parking enforcement police \rightarrow taps
 - Reintroduced jump start and flat tire service
 - Increased citation fine amounts
 - Because amounts have not increased in 13 years
 - Seen significant increase in compliment behavior
 - Staffing increases
- Sustainability / TDM
 - E-bike share introduced
 - 4000 memberships to campus affiliates
 - Vanpool
 - 16 routes

 - Training new drivers
 - Working toward new buses
